Dear Mr. Gawlikowski:

Judge Hellums referred your letter of February 22, 2010 and forwarded it to me for review and response. In your letter, you ask the judge to provide you with:

1. "Any and all emails sent to the Honorable Judge Bonnie Hellums by Wendy Burgower of Burgower & Rainwater LLP on October 22, 2009 related to [trial court] cause number 2003-67714." (emphasis in the original)
  - Judge Hellums received no emails or any other communication from Wendy Burgower on October 22, 2009. Ms. Burgower, however, did send emails to the judge on October 8, 2009, and October 15, 2009. (See attached.)
2. "Any and all emails sent to any staff member of the 247<sup>th</sup> Family District Court by Wendy Burgower of Burgower & Rainwater LLP on October 22, 2009 related to [trial court] cause number 2003-67714." (emphasis in the original)
  - No such records exist. After an inquiry, it appears that no one on the staff of the 247<sup>th</sup> District Court received any emails from Wendy Burgower related to trial court cause number 2003- 67714.
3. "Any and all emails sent by the Honorable Judge Bonnie Hellums to Wendy Burgower of Burgower & Rainwater LLP on October 22, 2009 related to [trial court] cause number 2003-67714." (emphasis in the original)
  - No such records exist. Judge Hellums did not send any emails to Wendy Burgower related to trial court cause number 2003-67714.

4. "Any and all emails sent by any staff member of the 247<sup>th</sup> Family District Court to Wendy Burgower of Burgower & Rainwater LLP on October 22, 2009 related to [trial court] cause number 2003-67714." (emphasis in the original)

- No such records exist. After an inquiry, it appears that no one on the staff of the 247<sup>th</sup> District Court sent any emails to Wendy Burgower related to trial court cause number 2003- 67714.
