Order

(1) The Court orders that DANIEL EDWARD GAWLIKOWSKI is to pay BRANDI MCDONALD SIKES \$45,000.00 on or before November 29, 2009, at 7719 Betty Jane Lane, Houston, TX, 77055. If such amount is not paid on or before November 29, 2009, the amount owed shall be reduced to a money judgment payable to BRANDI MCDONALD SIKES.

(2) The Court orders that Walter P. Mahoney, Jr., counsel for DANIEL EDWARD GAWLIKOWSKI, is to pay BRANDI MCDONALD SIKES \$5,000.00 on or before November 29, 2009, at 7719 Betty Jane Lane, Houston, TX, 77055. If such amount is not paid on or before

November 29, 2009, the amount owed shall be reduced to a money judgment payable to
BRANDI MCDONALD SIKES.
